## President’s message

I am delighted to welcome ISU Athletics as a new sponsor for this newsletter. Athletics has played a critical part in many of our lives and careers, from giving us thrills as spectators and participants to providing a foundation for so many students. The article on page 6 (*Student–Athletes maintain academic excellence*) describes the academic success of our athletes. Welcome Aboard!

On September 3, ISU President Larry Dietz joined us for lunch at the ISU Fall Luncheon in the Old Main Room at the Bone Student Center. Over 100 annuitants heard President Dietz present a welcome and upbeat message about ISU, current trends, and the future of our beloved institution. President Dietz discussed positive enrollment trends, university initiatives, and record-setting fundraising over the past several months. ISU truly is the envy of the other universities in Illinois, and even elsewhere. Our thanks to the new ISU President for graciously sharing his time and positive message with us.

The news on the legal front is guardedly optimistic. The Circuit Court in Sangamon County is where the SUAA case challenging the constitutionality of the state’s new pension statute will be heard, together with the cases filed by other groups and individuals. That count may have ruled by the time this newsletter appears. Given lead times, it is extremely difficult to present current news since legal matters can change daily. For the most up-to-date news, check the SUAA website, [www.suaa.org](http://www.suaa.org). I especially urge you to watch the interviews with Aaron Maduff, the lawyer handling the case on behalf of SUAA. He is an impressive person and experienced litigator who provides an excellent perspective and background on the latest in the cases.

We are in a much better position than we were even a few weeks ago. In July, the Illinois Supreme Court ruled in the *Kanerva* case that SB 1313, dealing with the deduction for health insurance, was unconstitutional as a diminishment of pensions. While the state of Illinois did not file an affirmative defense based on the reserved sovereign powers defense (the “police powers”) in that case, the Supreme Court used language indicating that the reserved sovereign powers argument may not apply in the face of the constitutional prohibition against diminishment of pensions. SUAA attorneys have used language from that case as a basis for moving to strike the reserved sovereign powers defense in the main case involving the constitutionality of SB 1.

The court in Sangamon County seems to be moving those cases to a “fast track,” whereby discovery, including depositions and other matters, will either not take place immediately or will take place on an expedited basis in order to hear the motion to strike and the state’s answers. By the time you see this, several dates will have passed and other things will have happened. The estimate now is that the court could have heard these cases and will make decisions by late fall or early winter. The cases will then go to the Illinois Supreme Court, which will take several months into 2015. The Supreme Court can take as long as it wants to decide the case.

Meanwhile, the injunction against enforcement of SB 1 remains in effect. We believe that the AAI for January 1, 2015, will take place as a result.

The *Kanerva* case is also not over. There are two aspects still to be resolved. First, it is clear that CMS will no longer be deducting health insurance premiums from pensions. SUAA attorneys and others were instrumental in making sure that, in light of *Kanerva*, the deductions would no longer take place. The deduction for insurance premiums was not taken in the October check. Second, SUAA attorneys have filed for a judgment that would return the premiums that have already been paid. That part of the case is still to be heard, and that may take some weeks or months for resolution.

The summer months have been very positive for us on the legal front, but the cases are not over. It is clear that much more work and time will have to be expended before we can claim victory. That means, of course, that the attorneys' fees and other costs will continue to mount. ISUAA has stepped to the plate on more than one occasion to assist with fees, as have a number of you. ## How Time Flies

### 150 Years ago–1864

- In the early years of the University, there was no dedicated student housing on campus. Many students boarded with faculty and administrators, even the University president (referred to as the principal). Information on student housing in the 1864 catalog reads: "Board can be obtained in good families for about \$4 a week, exclusive of fuel, lights, and washing; when these are furnished, except washing, the charge is a little more." Expectations of student relationships with their hosts was also outlined in the catalog: "Experience has shown it to be very necessary that a perfect understanding should exist between the principal and those with whom the students board, in respect to the habits and conduct of students at their rooms. This will accordingly be carefully attended to." Illinois State Normal University, Catalogue of the State Normal University for the Academic Year ending June 23, 1865 (*The Daily Pantagraph*).

### 100 years ago–September 1914

- Though some student housing was available, student living space was limited. Students were still boarding with area residents, faculty, and administrators. Lists of available rooms were kept with faculty members Lillian Barton, Elmer Cavins, and Harrison Russell. As students were assigned housing members of local Christian associations would escort students to their new rooms.
- The University's two debating societies, the Wrightonians and Philadelphians, were gearing up for the new year with announcements in *The Vidette*. In their column, the Wrightonians poked a bit of fun at the Philadelphians over last year's contests: "The Wrightonian society is looking forward to a successful year, although the Phils won last year. The Wrights

had nearly everything for the two years before that.” *The Vidette*, September 12, 1914.

- Ann George, the first American woman to study under Maria Tecla Artemesia Montessori, spoke on campus September 21 to a student audience. *The Vidette*, September 30, 1914.

### 75 years ago—September 1934

- Raymond Fairchild filled 15 instructional positions at the University, seven of them with the Illinois Soldiers and Sailors Children’s Schools (ISSCS). O.R. Bontranger was appointed as the new ISSCS principal while Henry Herbert was named the new ISSCS band and orchestra director. *The Vidette*, September 10, 1934.
- WJBC moved from its studios in LaSalle to the “Old Castle Tower” (now known as Cook Hall) to broadcast to the ISNU campus: “The voice of Normal university can now be heard on the air over radio station WJBC, which has been moved from LaSalle to Bloomington and Normal, operation on a frequency of 1200 kilocycles.” *The Vidette*, September 14, 1934.
- In an effort to build campus unity and invoke school spirit, Fairchild reinstated weekly assemblies for the campus. Students were to attend two assemblies a week with an option for a third hour. *The Vidette*, September 25, 1934.

### 50 years ago—September 1964

- Official enrollment for the new school year hit 1,637 – a new high for the campus. *The Vidette*, September 28, 1964.
- Because the number of incoming students was so large, housing officials had a difficult time finding room for all students. For several weeks, about 40 women lived in barrack-style

accommodations in one of the lounges of Atkins-Colby until more permanent housing could be found for them. *The Vidette*, September 17, 1964.

- William Holt, English senior, won a contest for a rewrite of the university’s marching song. Because the school dropped “Normal” from its name earlier in the year, the old marching song was out of date. Holt won \$50 and recognition at the Homecoming game later that year. *The Vidette*, September 17, 1964.
- The University Club bought a 1922 fire truck for use at parades and sporting events. The truck was purchased from the Granite City Council for one 1922 silver dollar. *The Vidette*, September 28, 1964.

### 25 years ago – September 1984

- ISU Football beat Lincoln University (Lincoln College) 54-0 in a major rout. This was the third largest victory margin at the time in ISU football history. *Daily Vidette*, September 4, 1984
- In the wake of the Beer Riots, a full-page ad was placed in the *Daily Vidette*, informing students of the Town of Normal’s new “mass gathering” permit law. Gatherings of more than 300 people needed to apply for a Mass Gathering Permit and adhere to a number of stipulations that included the monitoring of alcohol consumption and a required number of restroom facilities per number of gathered attendees. *Daily Vidette*, September 6, 1984
- For the first time in university history, enrollment exceeded 20,000 with 20,134 students. *Daily Vidette*, September 4, 1984

- On the night of September 24, 1984, after the Cubs clinched the National League's Eastern Division title, a group of more than 400 students paraded through campus and the town of Normal. Though Normal Police Sgt. Dennis Saunders described the scene as a "joyful type of deal," the revelers tore down the sign for Normal City Hall, threw garbage cans and leaflets around the main floor of Milner Library, and tore down a goal post at Hancock Stadium. *Daily Vidette*, September 25, 1984

## Student-Athletes maintain academic excellence

The NCAA released its annual Academic Progress Rate (APR) report, and it was all positive for Illinois State, as all 15 sports equaled or exceeded the national average for public universities in their sport. The APR measures eligibility, graduation, and retention each semester or quarter and provides a clear picture of the academic performance for each team in each sport. The most recent APRs are multi-year rates based on scores from the 2009-2010, 2010-2011, 2011-2012, and 2012-2013 academic years.

“Once again we are pleased with our latest APR results,” said Cindy Harris, senior associate director of Athletics for Compliance & Student Services. “They certainly demonstrate that our student-athletes are focused and dedicated to succeeding in the classroom. Our coaches, academic advisors, and other administrative staff provide a quality support structure that assists our many student-athletes to achieve their academic goals and to graduate.”

Among the 15 squads, eight earned perfect single-year (2012-2013) APR scores including men’s and women’s golf, men’s tennis, women’s cross country, women’s indoor and outdoor track and field, softball, and volleyball. With perfect multi-year APR scores of 1,000, the Redbird golf squads ranked in the top 10 percent of their respective sports and earned NCAA Public Recognition Awards for achievement.

It is no surprise the athletic department scored well in the APR report, as Redbird student-athletes have a history of performing well in the classroom. In the spring of 2013, the Redbirds had a department grade point average (GPA) of 3.13, while several programs set team GPA records.
